

**GRAND RAPIDS CHARTER TOWNSHIP
REGULAR TOWNSHIP BOARD MEETING
June 7, 2016**

A meeting of the Grand Rapids Charter Township Board was called to order at 7:00 pm by Supervisor Michael DeVries. The meeting was held in the Township Hall. 3. APPROVE MINUTES OF THE REGULAR TOWNSHIP BOARD MEETING OF MAY 17, 2016.
