

**GRAND RAPIDS CHARTER TOWNSHIP  
REGULAR TOWNSHIP BOARD MEETING  
OCTOBER 21, 2008**

A meeting of the Grand Rapids Charter Township Board was called to order at 7:00 pm by Supervisor Michael DeVries. The meeting was held in the Township Hall. The following were present: Supervisor Michael DeVries, Treasurer Chris Afendoulis, Clerk Janice Hulbert and Trustees Rusty Merchant, Edward Robinette, James Saalfeld and Lee VanPopering. There were 5 people in the audience.

**3. APPROVE MINUTES OF THE REGULAR TOWNSHIP BOARD MEETING, OCTOBER 7, 2008.**

**8. REPORT TO GRAND RAPIDS TOWNSHIP BOARD REGARDING MEIJER GARDENS CONCERT COMPLAINTS.**

At a Township Board meeting on August 19, 2008, neighbors of Meijer Gardens spoke to the Board requesting assistance with their problems with the noise level from the concerts at Meijer Gardens. The Board appointed Michael DeVries and James Saalfeld to research the Planning Commission and Township Board regulations regarding concerts at Meijer Gardens.

Michael DeVries and James Saalfeld presented REPORT TO THE GRAND RAPIDS TOWNSHIP BOARD REGARDING CITIZEN COMPLAINTS ABOUT MEIJER GARDENS CONCERTS as attached.

James Saalfeld gave a summary of the report and recommendations.

**9. CONSIDER CERTIFYING DELINQUENT SEWER/WATER BILLS TO THE WINTER TAX ROLL**

Sue Cady, Deputy Treasurer, submitted a list of delinquent sewer and water bills, requesting permission to attach those bills to the 2008 winter tax roll.

Lee VanPopering, seconded by Edward Robinette, moved to approve certifying the attached delinquent sewer and water bills to the 2008 winter tax roll. Motion passed unanimously.

**10. CONSIDER AUTHORIZATION TO PURCHASE REPLACEMENT COMMAND VEHICLE.**

Bob Radakovitz, Director of Public Safety, requested permission to order a new command vehicle, not to exceed \$30,000. The command vehicle will replace the current command vehicle which will go in service as the Medical Response Unit, as agreed in the Addendum to the Ambulance Service Agreement. Ownership of the current vehicle will be transferred to Rockford Ambulance.

Lee VanPopering, seconded by Edward Robinette, moved to approve the purchase of a new command vehicle as requested, and transfer ownership of the current vehicle to Rockford Ambulance. Motion passed unanimously.

**11. CONSIDER AUTHORIZATION TO PURCHASE WINDOW SHADES.**

Bob Versluys, Facilities Manager, requested replacement of existing blinds in the offices to better control heat in the summer. Mr. Versluys recommends accepting the quote from The Shade Shop in the amount of \$4,060.

Lee VanPopering, seconded by Edward Robinette, moved to approve the purchase of blinds for the offices from The Shade Shop in the amount of \$4,060. Motion passed unanimously.
