## NEWS BRIEF - FEBRUARY 2015 -

Grand Rapids Township finished 2014 with a General Fund surplus, thanks to a generous donation for the East Beltline Recreational Trail from Spectrum Health, in addition to the 2014 road and trail capital projects coming in under budget.

The surplus has been transferred to the Endowment Funds, along with a cell tower lease extension bonus that was received for the site behind the Township Hall. The Endowment Funds were created last year to provide for the long term care of the Township's public facilities including; parks, trails, buildings, the courthouse plaza and the East Beltline median. The Township Board is preparing for the future when increases in property values are tempered by the limits for growth within the Township.

The Great Recession illustrated that the growth that provided Grand Rapids Township the revenues to add parkland, build trails and maintain facilities, all without borrowing money, will not go on forever; therefore the Endowment Funds are essential for a sustainable future of low tax rates.

### 2015 Construction Projects

- ◆ The Forest Hills/Greenbrier neighborhood roads will be replaced this summer; in addition the roads in the Vineyards neighborhood will be resurfaced.
- ◆ A sanitary sewer line will be extended on Dean Lake Avenue, south of 3 Mile Road.
- ◆ Crahen Valley Park will have the valley bridge constructed in addition to an extension of the ridge trail that was started last year.

### MAY 5<sup>TH</sup> STATE WIDE ELECTION

#### Where the \$1.6 Billion in new revenue comes from;

- ◆ SALES TAX WILL NO LONGER BE CHARGED ON FUEL
- ◆ INCREASE IN SALES TAX FROM 6% TO 7%
