**NOTICE OF PUBLIC HEARING**

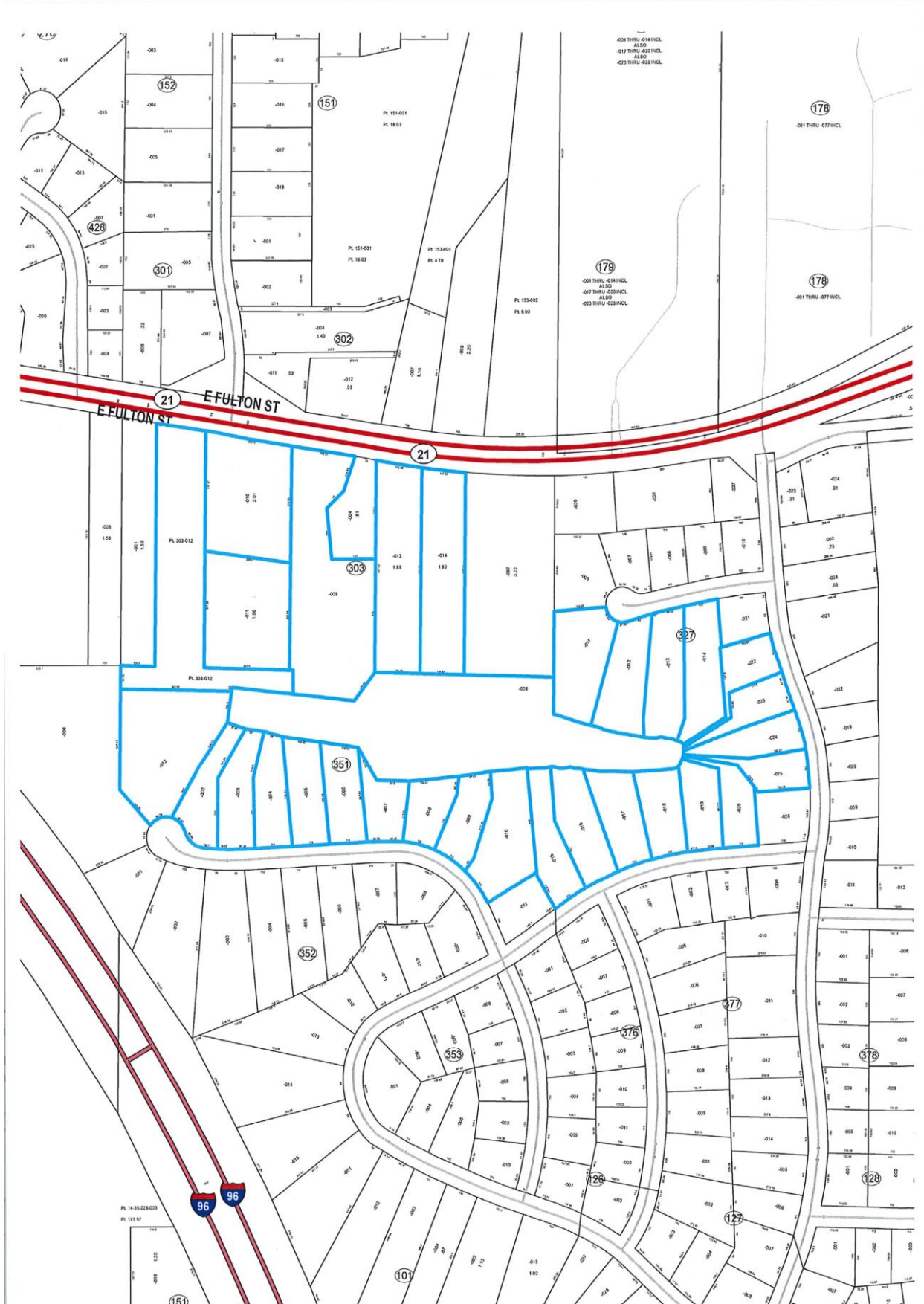
NOTICE IS HEREBY GIVEN that the Township Board of the Charter Township of Grand Rapids, Kent County, Michigan, having exercised the powers provided to the Township Board pursuant to Act 188 of the Public Acts of Michigan of 1954, as amended, to make certain public improvements to Echo Lake consisting of the application of herbicide treatments and/or mechanical harvesting for the eradication or control of aquatic weeds and plants. The Township Board has tentatively determined that the cost of said Improvements shall be specially assessed against each of the following described lots and parcels of land which are benefitted by the Improvements and which together comprise the following proposed special assessment district:

TAKE NOTICE that the Township Board of the Charter Township of Grand Rapids will hold a public hearing on July 2, 2019, at 7:00 p.m., or shortly thereafter, at the Township Hall, 1836 East Beltline NE, Grand Rapids, Michigan, to hear and consider any objecting petitions filed, objections raised, the proposed Improvements, the proposed special assessment district, and all other matters relating to said Improvements.

TAKE FURTHER NOTICE THAT AN OWNER OR A PARTY IN INTEREST IN A LOT OR PARCEL OF LAND SUBJECT TO A SPECIAL ASSESSMENT MAY FILE A WRITTEN APPEAL OF THE SPECIAL ASSESSMENT WITH THE MICHIGAN TAX TRIBUNAL WITHIN THIRTY (30) DAYS AFTER THE DATE OF CONFIRMATION OF THE SPECIAL ASSESSMENT ROLL, BUT ONLY IF SAID OWNER OR PARTY IN INTEREST APPEARS AND PROTESTS THE SPECIAL ASSESSMENT AT THIS HEARING. An appearance may be made by an owner or party in interest, or his or her agent, in person or, in the alternative, an appearance or protest can be filed with the Township by letter prior to the hearing, in which case a personal appearance at the hearing is not required.

PROPERTY SHALL NOT BE ADDED TO THE PROPOSED SPECIAL ASSESSMENT DISTRICT AND THE ORIGINAL ESTIMATE OF COST SHALL NOT BE INCREASED BY MORE THAN 10% OF THE ESTIMATED INCREASE AMOUNT WITHOUT FURTHER NOTICE AND PUBLIC HEARING.
