BUDGET AMENDMENT

The 2012 General Fund Budget included \$380,000 to transfer to other funds: \$6000 to the East Beltline Gateway Partnership Fund, \$12,000 to the Pathways Fund, and \$368,000 to the Improvement Revolving Fund. The \$368,000 amount was in error by \$6000 excess. Supervisor DeVries asked to amend the budget by adjusting line item 246-000-998 to \$362,000, which now matches the intent to transfer a total of \$380,000 from the General Fund.

Lee Van Popering, seconded by Rusty Merchant, moved approval of the budget amendment.

7. CONSIDER REQUEST TO AUTHORIZE TOWNSHIP HALL BUILDING REPAIR.

Lee Van Popering, seconded by Rusty Merchant, moved approval of the bid of \$3335.00 by the S.A. Morman Co. for replacement of 3 exterior steel doors on the Township Hall. Motion passed unanimously.

8 DISCUSSION OF PROPOSED CHANGES TO TOWNSHIP BURN ORDINANCE.

Public Safety Director Robert Radakovitz presented a draft of proposed changes to the Township Ordinance to allow for recreational fires. A discussion was held, and an Ordinance will be prepared for a future meeting.

9 CONSIDER APPROVAL OF INVOICE FOR PLANNING SERVICES

Rusty Merchant, seconded by Lee Van Popering, moved approval of paying the invoice for Planning Services as presented. Motion passed unanimously.
